#### 3 DAY PRAXIS FRAMEWORK FOUNDATION COURSE

By the completion of the training a participant will be able to understand:

#### 2 DAY PRAXIS FRAMEWORK PRACTITIONER COURSE

This program builds on the knowledge gained at Foundation level, by providing participants further understanding on tailoring and applying the Praxis Framework to an organisation's projects or programmes. The program is also designed to prepare participants for the Praxis Framework Practitioner exam, which is completed at the end of the program. Passing the Foundation exam is a pre-requisite to completing the Practitioner exam.

#### 3 DAY PRAXIS FRAMEWORK BRIDGING COURSE

This course allows those holding the following certifications to complete the Practitioner level without needing to complete the Foundation level first: PRINCE2, PMP, MSP, APM PFQ or PMQ, IPMA Level D (or equivalent). The Bridging Course is specifically designed for those who have previously undertaken training and have an above-mentioned certification, but are seeking a more integrated framework. The course covers the similarities and differences between the Praxis Framework and other prominent approaches. It aims to bridge any knowledge gaps between the Praxis Framework and other certifications, whilst also preparing participants for the Praxis Framework Practitioner exam. The Practitioner exam is completed at the end of this program.
